Subj: CHANGE IN DELEGATION OF AUTHORITY FOR COMMANDER, FLEET  
AIR KEFLAVIK (COMFAIRKEF) AND DETACHMENTS, KEFLAVIK,  
ICELAND

(b) SNDL (OPNAVNOTE 5400 Series)

1. Purpose. To change reporting procedure for subject fleet activity and detachments under the command and support of the Chief of Naval Operations per reference (a).
2. Background. This modification will realign COMFAIRKEF from Commander, U.S. Atlantic Fleet claimancy and chain of command to Commander, U.S. Naval Forces Europe claimancy and chain of command. The change results from a modification in the Unified Command Plan signed by the President on 30 April 2002. The Unified Command Plan moves the Iceland area from Joint Forces Command responsibility to European Command responsibility. This action moves COMFAIRKEF under the Navy Component Commander who supports the Combatant Commander with Iceland area of responsibility. There will be no change in the organizational structure or mission for COMFAIRKEF or either of the detachments.
3. Organizational Change. Revise reporting procedures for COMFAIRKEF effective immediately. The following applies:
